\$225	<p>Private Party Fee - includes the pool, closed to all members and guests, for you to use. Private parties are booked only during extended swim hours only. Lifeguard fee is separate and required as part of the rental.</p>
OR	
\$150	<p>Semi-Private Party Fee - includes use of a portion of the pool deck, to be set upon your discretion and all items returned to their original spots. The pool is still open for members during this time. Lifeguard fee is separate and required as part of the rental.</p>
Payment Process-Pool Rental	<p>Place your check in the mailbox as you enter the pool. The mailbox is on the left, just past the Large McCarter sign on the corner when you enter. Reach out to Lauren Good if you would prefer to hand it in person.</p> <p>- On Check be sure to indicate {PARTY LAST NAME AND DATE}</p>
Securing Lifeguards \$30/guard per hour	<p>There is a new way that Upstate Pools is handling their lifeguard requests. There is an online form you'll fill out and send in, requesting how ever many lifeguards you'll need for your event. If you have under 50 guests, then just 1 lifeguard is needed for that request. Any guest count over 50 guests will require 2 guards.</p> <p>Then, you'll bring a check with you, made out to UPSTATE POOLS and hand it to the guard when you arrive.</p>

- **Decorating:** You are welcome to decorate the pool for a party but you may not ask members to move if you decide to begin setting up prior to your party time. There are tables you can use in the mens restroom.
- **Responsibilities:** under the rental agreement, the responsible party is responsible for:
 - Pay fee to McCarter as listed above to McCarter.
 - Fill out the Party Request [LINK](#) for Upstate Pools to schedule guards.
 - Pay Lifeguard fees as listed above.
 - No glass of any kind is allowed at the pool for any reason.
 - You will need to return all borrowed chairs/tables/grills to the appropriate locations.

- Return all lounge chairs back surrounding the pool deck neatly for members.
- Ensure there are at least 4 chairs at each round table borrowed.
- Remove all decor.
- All party trash should be picked up around the deck and all items are taken to the large dumpster.
- Guests that are NOT members of McCarter must leave when the lifeguard and/or responsible party leaves - guests may not stay at McCarter on their own unless they are a member with extended swim.
- A clean up fee of \$75 will be charged if the pool is not left in the above condition following a party. We suggest taking a quick photo when you leave.
- Please note, there are cameras in and around McCarter Community Pool which may be accessed in case of a discrepancy.
- This rental agreement will be canceled if the contract is not signed and returned (email /digital signature okay)
